

Regarding Electricity (power) surcharge

Copenhagen Malmö Port AB has 1st of January 2023 introduced a new electricity (power) surcharge applicable for all operational charges.

Why an Electricity (power) surcharge?

The Danish and Swedish economies are bracing for tough times:

- Inflation levels in Denmark and Sweden are at levels that haven't been seen for more than 30-40 years.
- In Denmark, inflation is running at 9.9%¹. In Sweden, the latest annual inflation is 9.0%²
- Diesel, gas, and electricity prices are likewise surging.
- The cost of building materials has been elevated for some time.
- Interest rates are being lifted to taper inflation.

These elements impact CMP's business in more than one way:

On the one hand, the cost of labour, materials, maintenance costs, the cost of land, and the cost price of new investments are all going up. The cost of running our machinery – whether they are electric or running on bio- or fossil fuels – is now around 60% higher than in 2021.

On the other hand, high inflation is often followed by a recession as consumers and businesses hold back spending. This is supported by consumer confidence which is now lower than at the time of the financial crisis of 2009³.

With these considerations, we take the update of the 2023 pricelist seriously – which also includes an Electricity (power) surcharge. The cost increases must be recovered in our revenues and since we are bearish on volumes in general, price increases are the only option.

Consequently – in addition to charge increases of 4-7% below current inflation – CMP has introduced electricity (power) surcharge.

What is the Electricity (power) surcharge?

The electricity (power) surcharge is introduced as of 1st of January 2023. This surcharge will vary with the cost of electricity in the electricity sectors DK2 and SE4. The surcharge will apply to all operational charges and enable us to recover cost increases above the electricity costs in 2021. The surcharge will be applied to all operational charges regardless of whether a specific operation is directly linked to electricity consumption. This approach is applied to share the increased cost among our customers. The surcharge level is adjusted quarterly and will revert to 0% as soon as the cost of electricity is back at normal levels.

How we arrive at the level of Electricity (power) surcharge?

An electricity (power) surcharge applies to all handling (operational) charges. The surcharge is based on the official price for kWh in the electricity sector DK2 in Denmark and SE4 in Sweden. The electricity prices are available on:

The surcharge is updated quarterly prospectively basis the average of previous three months period with one month's lag (e.g. the surcharge for Q1 (Jan-Mar) 2023 is determined basis the average kWh price for the period Sept-Nov in 2022).

Based on a calculated 3-month average of official electricity price, the Electricity (power) surcharge for Denmark and Sweden is settled based on tables below:



How to calculate of Q1 Electricity (power) surcharge?

Q1 2023 calculation of Electricity (power) surcharge based on:

1) Development of electricity prices in Denmark and Sweden:



---- Price avg. monthly

01-11-2022

Nov: 1,35

Oct: 0,81

- 2) Calculation of 3-month average and surcharge:
- Copenhagen: (2,45 + 1,02 + 1,08)/3 = 1,51 DKK / kWh (3-month average) Based on this average: surcharge in Q1 2023: 1%
- Malmo: (2,42 + 0,81 + 1,35)/3 = 1,53 DKK / kWh (3-month average) Based on this average: surcharge in Q1 2023: 4%

Consequently, for Q1 2023 Electricity (power) surcharge:

- Copenhagen +1%, which applies to all operational charges
- Malmo: +4%, which applies to all operational charges
